(Lion) applauds the Wyoming Department of Transportation's (WYDOT) prioritization of zero-emission vehicle (ZEV) infrastructure deployment throughout the Great State of Wyoming. WYDOT's ZEV Infrastructure Strategic Plan Request for Information (RFI) is a strong signal to the rest of the nation that Wyoming is beginning its journey to improve air quality through its forward-thinking Plan to increase ZEV adoption.

As the leading Original Equipment Manufacturer (OEM) of purpose-built, all-electric medium and heavy-duty vehicles, including zero-emission school buses, zero-emission trucks, and zero-emission shuttle buses, we have successfully deployed these vehicle types in California, Florida, New York, Massachusetts, Minnesota, and other states across the nation. With over 400 electric vehicles on the road throughout North America, we offer an industry-leading 200 miles of range with our all-electric Class 6 and Class 8 trucks and 155 miles of range with our all-electric buses. Lion is also proud to have announced the opening of our state-of-the-art, automated facility in Joliet, Illinois, that will build up to 20,000 medium- and heavy-duty electric vehicles per year. This new shell building of 900,000 square feet — 80% of it is completed – will be the largest all-electric medium- and heavy-duty vehicle plant in the US, with the first vehicles expected off the production line in H2, 2022.

Lion strongly supports WYDOT's efforts to improve statewide air quality through the implementation of a ZEV Infrastructure Strategic Plan. The effective deployment of charging infrastructure throughout Wyoming will directly increase ZEV adoption in the state and lead to reduced greenhouse gas (GHG) and criteria pollutant emissions generated by gas- and diesel-fueled vehicles. As the leading medium- and heavy-duty electric vehicle manufacturer, Lion supports WYDOT's Plan to establish a strategic charging infrastructure corridor.
